The American Health Information Management Association (AHIMA) respectfully submits the following comments on proposed ICD-10-CM Addenda modifications presented at the March ICD-10 Coordination and Maintenance (C&M) Committee meeting and being considered for October 1, 2023 implementation.

AHIMA is a global nonprofit association of health information (HI) professionals. AHIMA represents professionals who work with health data for more than one billion patient visits each year. AHIMA's mission of empowering people to impact health drives our members and credentialed HI professionals to ensure that health information is accurate, complete, and available to patients and providers. Our leaders work at the intersection of healthcare, technology, and business, and are found in data integrity and information privacy job functions worldwide.

We support the proposed ICD-10-CM Addenda modifications presented for October 1, 2023 implementation.

Additionally, we recommend that the following proposed Addenda changes presented for October 1, 2024 implementation be considered for implementation on October 1, 2023. These changes represent error corrections or significant clarifications that we believe should become effective earlier than October 1, 2024 in order to facilitate proper coding and improve the quality of coded data.

Tabular Modifications That Should Become Effective October 1, 2023 Instead of October 1, 2024

G93.4 Other and unspecified encephalopathy

Delete Excludes1: alcoholic encephalopathy (G31.2)

encephalopathy in diseases classified elsewhere (G94)

Add Excludes2: alcoholic encephalopathy (G31.2)

encephalopathy in diseases classified elsewhere (G94)

H26.21 Cataract with neovascularization

Revise Code also, <u>if applicable</u>, associated condition, such as:

chronic iridocyclitis (H20.1-)

K59.0 Constipation

Excludes1: fecal impaction (K56.41)

Delete incomplete defecation (R15.0)

Add Excludes2: incomplete defecation (R15.0)

P28.5 Respiratory failure of newborn

Delete Excludes1: respiratory arrest of newborn (P28.81)

Delete respiratory distress of newborn (P22.0-)

Add Excludes2: respiratory arrest of newborn (P28.81)

Add respiratory distress syndrome of newborn (P22.0)

R41 Other symptoms and signs involving cognitive functions and awareness

Excludes1: dissociative [conversion] disorders (F44.-)

Delete Excludes1: any condition classifiable to \$06.4 \$06.6

S22 Fracture of rib(s), sternum and thoracic spine

Revise Code first, <u>if applicable</u>, any associated <u>condition such as</u>:

injury of intrathoracic organ (S27.-) spinal cord injury (S24.0-, S24.1-) traumatic hemothorax (S27.1-)

Add traumatic hemothorax (S27.1-)
Add traumatic pneumothorax (S27.0)
